#### Winona Fine Arts Commission 2021 Grant Application Guidelines

Mission: The Winona Fine Arts Commission exists to promote, educate and facilitate efforts concerning the performing, literary and visual arts in the Winona area. The Commission serves as a resource for the community, artists and art organizations, and serves in an advisory capacity to the City Council on arts and humanities initiatives.

#### The Opportunity

The FAC will offer grants intended to assist creatives and organizations in continuing their practice and operations during this extended period of the coronavirus pandemic. A specific project proposal is not required for these grants, although some applicants may discuss how funding would impact upcoming projects as part of their application. Up to six individuals and/or organizations will be awarded one-time grants of up to \$500 each. Should the FAC wish to extend funding to additional applicants, funds may be drawn from the Blue Heron Fund for this purpose.

## <u>Eligibility</u>

The FAC will consider requests from individual artists and non-profit organizations in the Winona area whose work or creative practice continues to be impacted by the coronavirus pandemic. An individual's permanent address or an organization's business address must be within Winona city limits. Both emerging and established individuals and organizations are encouraged to apply.

#### Funding Criteria

The FAC will consider the following criteria, as demonstrated through the application narrative and supplemental materials:

- Artistic merit, as demonstrated through the application narrative and supporting documentation, such as resumes and work samples
- Financial need, as demonstrated through the application narrative
- How the individual or organization contributes to the cultural landscape of Winona
- Likelihood of funding to help sustain and assist in the individual or organization in contributing to the cultural landscape of Winona

#### Award Process

Applications will be reviewed by the FAC at their Nov. 2 meeting. Applications selected for funding will be recommended to City Council at the next regularly scheduled meeting. City Council will give final approval regarding the recommended allocation of FAC funds.

Application Deadline: Friday, October 15, 2021

#### Grant Application Period

September 21, 2021 – October 15, 2021. Grants should be put to use for immediate need but if designated for a project or program must be used by December 1<sup>st</sup>, 2022.

## Reporting Requirements

Grantees will submit to the FAC a final report detailing the impact of grant funds on the grantee's work during the grant period. Reports shall be due to the FAC no later than November 30, 2021.

Please note, if samples exceed the indicated length, only the first portion of the samples up to the above indicated maximum will be reviewed.
